

CONSTITUTION OF SALESFORCE STUDENT CHAPTER

Article I. Name of Organization – Salesforce Student Chapter

Article II. Statement of Purpose

Salesforce Student Chapter strives to provide UTD students a training on Salesforce CRM technology through workshop sessions. Students will also be provided with an opportunity to network with industry professionals. Students will learn how to use Sales, Marketing, Service and other clouds of Salesforce along with their applications in different business models.

Article III. Membership

Section 1. Membership shall be open to students of The University of Texas at Dallas regardless of sex (unless specifically exempt by law), race, color, religion, age, national origin, disability or veteran status.

Article VII Organization Advisor

Section 1. Current Advisor – Prof. Mark Thouin, Director MS ITM Program

Selection procedure of new advisor to initiate whenever current advisor resigns from the advisor role voluntarily or leaves the University.

Selection Procedure of new advisor can also begin whenever voting members decide to Change the advisor for any reason.

Before initiating the change of advisor it is mandatory to consult with the current

Advisor atleast once.

Article VIII Organization Funds

Funds to be collected in form of membership fees from new members. Price of membership fees to be decided by voting members before start of every semester. SOC Organization funds can also be collected to fund for conducting events every year. Student Organization needs to be in good conduct to receive the funds.

Article IX Method to Amend the constitution

Any changes required to the constitution shall be done on agreement from Executive Officers and Advisor. President of the club to request SOC to make the changes by keeping Vice President and Advisor in the email communication.

Article X Dissolution of Clause

Section 1 In case of resignation of President from the club Vice President to take over the position for next 2 weeks. Advisor of the club along with voting members to decide the next President. On resignation of Vice President . Secretary to take his position until new officer has taken Vacant Position. Resignation shall be communicated to Executive Officers and Advisor.

Section 2 IF student organization itself dissolves then all the funds shall be used to get Salesforce Admin certifications to the students chosen by Advisor. Number of students to whom certification exam vouchers to be given shall be dependent on funds available.

Article XI Enabling Clause

This Constitution shall go in effect on August 1st 2018 upon approval of 100 percentage of votes in favor by all present voting members. This constitution shall replace and render null any and all previous constitutions, procedures, practices and precedents for this organization.
